## **Detroit Airport Airfield Operations Director to Represent Airport Cooperative Research Program**

**DETROIT (February 9 , 2015)** - Dianne Walker, Director of Airfield Operations for Detroit Metropolitan Airport and Willow Run Airport has been selected as an Ambassador for the Airport Cooperative Research Program (ACRP), an industry-driven, applied research program that develops near-term, practical solutions to problems faced by airport operators. ACRP is managed by the Transportation Research Board of the National Academies and sponsored by the Federal Aviation Administration.

Airports submit research ideas or “problem statements” to ACRP and comprehensive studies are conducted on those issues which are likely to benefit a broad range of airports.

Examples of studies recently published for the benefit of airports include: “*Airport Terminal Incident Response Planning;*” “*Prototype Airport Sustainability Rating System-Characteristics, Visibility, and Implementation Options;*” “*Being Prepared for Irregular Operations, a Business Planning and Decision Making Approach;*” “*Guidebook for Successfully Assessing and Managing Risks in Airport Capital and Maintenance Projects;*” and “*Airport Escalators and Moving Walkways—Cost Savings and Energy Reduction Technologies.*”

As an Ambassador, Walker will represent ACRP at airport industry conferences and events during her two-year term.

“I am proud of Dianne, not only because it is an honor to be selected, but also because of her enthusiasm for sharing industry best practices among airports across the nation,” said Thomas Naughton, airport authority CEO. “The exchange of this information is a key factor in keeping our airport industry safe and efficient.”

Walker already is active in ACRP currently serving on an Irregular Operations panel.
